
## Libraries Events

Dear Parents/Guardians,

- Their willingness to stand for election should there be more than one application.
- Their consent for the circulation of their name and the classes attended by their child(ren) to all other parents/guardians, if they are willing to stand for nomination and election.

Depending on the number of applications, there may be further correspondence required in order for an election to take place. The Principal/Chairperson of the Board of Management will contact the relevant parties in this instance.

Please submit your email (as above) no later than 2p.m on Friday 3<sup>rd</sup> of February 2023.

### Role of Parent Nominee:

When considering whether or not you would like to put yourself forward for the role of parent nominee, please familiarise yourself with this position. While Parent Nominees are elected by parents, they are not representatives, nor do they represent the parent body. Parent Nominees are elected by the parent body to bring "a parent's view" to Board of Management deliberations. To this end, their contribution to the Board of Management is a very important one, but they are not required to consult with the wider parent population, take instruction from them or report back to them. As detailed in this week's newsletter the ideal nominee for the role would have experience in Health and Safety, SEAI Monitoring and Reporting experience, Building Maintenance experience and an interest/experience in School Policy, Data Protection and ICT.

Finally, I would like to take this opportunity to thank the outgoing parent nominee, Greg MacHale for his contribution and dedication to the Board of Management and the development of our school over the last number of years.
